



The following is guidance for all users of the club.

British Club Membership Card

Please present your British Club Membership Card at the Security Gate whenever you visit the Club. British Embassy Security Guards are under strict instructions not to allow a Member of the Club to enter the premises without presenting their physical membership card first. Your understanding and cooperation is appreciated.

Inappropriate Behaviour

Members are expected to treat fellow members, guests of members, Club staff, Embassy security staff, and any other person visiting the Club with respect and courtesy. Any form of harassment, discourteous, aggressive, and discriminatory behaviour, will not be tolerated.

Intoxicated behaviour

The Club staff are responsible for the safety of everyone in the Club and you could be asked to leave the Club should you become intoxicated and cause a nuisance. At the recommendation of the Club operator, in consultation with the British Chamber of Commerce Myanmar, offenders may be barred from the British Club Yangon either temporarily or permanently.

Confidentiality

Members and guests are expected to respect the privacy and confidentiality of other members and the Club itself.

Social media

Members are requested not to publicise the Club on social media. Photos of the surrounding FCDO estate are not permitted.

Dress Code

Members are requested to dress with respect to others using the club.

Use of Facilities

Members should use club facilities responsibly. This includes proper use of sports facilities, dining areas, and any other amenities.

Payments

Members are required to settle their account on the day of consumption. There are no credit facilities offered.





Guest Policies

Members are required to give advance notice of their guests to British Embassy Security Staff. Please email the following address no later than mid-day the day prior to access. Please state in the subject line "Club guest access request for (date)." Holders of British Club Yangon membership cards may invite up to four (4) guests.

Each guest must present a valid physical photo identification document such as a passport, driving license or national ID card when arriving at the Club, to the British Embassy Security Guards at the British Club Yangon entrance.

There should be no more than three (3) guest visits during any 12-month period, which would be monitored by the club operator and BCCM.

The Member is fully responsible for the behaviour of their guests and shall be present throughout the entire visit period of the guests. Members shall not drop off, register, and leave their guests unattended at the Club. In the event of this happening the Club Operator is authorised to ask the guests to leave the Club premises.

The Member is fully responsible for all payments to the British Club which shall be settled prior to departure from the Club premises on the day of consumption.

The British Embassy, Club and British Chamber of Commerce Myanmar reserve the right to update guest policies.

The member must return their British Club Membership Card when his/ her company decides not to renew its membership with the British Chamber of Commerce Myanmar to the Membership Team of BCCM - membership@britishchambermyanmar.com.

Please keep your membership cards safe. If you lose your membership card, it's important to inform the British Chamber of Commerce Myanmar promptly. There is a charge to the Member of 15,000MMK per card to re-issue lost or damaged cards.
