The British Chamber of Commerce Myanmar will consolidate the various regulations into one document. We cannot 100% confirm that all the reports are accurate and are intended as a guideline only. We will provide updates as and when new information emerges.

#### Resumption of Tourist Visa service on Online e-Visa System

- 1. The Ministry of Immigration and Population resumed the Online e-Visa services on 1 April 2022 for business visa applications to facilitate the entry of foreign investors and businessmen to Myanmar. Moreover, commercial international flights operations are allowed to operate in accordance with the COVID-19 rules and regulations of the Ministry of Health, and therefore, the number of foreign visitors to Myanmar has been increasing.
- 2. With an aim to develop tourism sector and to have a harmonized tourism with the neighboring countries, e-Visa (Tourist) applications will be allowed and accepted from 20 May 2022.
- 3. Requirements for the application of Online e-Visa (Tourist) will be available e-Visa Process.

### **Getting e-Visa Approval Within 4 Steps**

1. FILL IN THE SECURE ONLINE VISA FORM.

Applicant is required to enter all the necessary information in the visa form

2. **CONFIRM AND PAY** 

Applicant needs to verify all the information entered is correct before proceeding to the next step. Make the payment with Credit Card. Acknowledgement email with application reference code will be sent to applicant's email.

3. GET APPROVAL LETTER WITHIN 3 DAYS

Approval process may take up to 3 working days. Applicant will receive eVisa approval letter via email once approved. Print out the approval letter and bring along with passport. You will need to present it upon arrival.

4. GET EVISA STAMPED UPON ARRIVAL.

Upon arrival to Myanmar Immigration checkpoint, present eVisa approval letter and passport to Immigration officer and get the passport stamped.

## **Business Visa Application Process**

- 1. The applicant must be invited by a registered Myanmar company or a registered Chamber of Commerce Association. NGO/INGO's invitation letters are not eligible.
- 2. That kind of invitation letter and a company registration certificate of the company inviting the applicant must be submitted.
- 3. The invitation letter must be addressed to the applicant and state the purpose and the timeframe of the applicant's visit. The inviting company's status in Myanmar Companies Online (MyCO) must be registered.
- 4. The applicant must have the required COVID 19 related documents. (Detailed Information as below).
- 5. Inbound Travel Accident Insurance Policy with COVID-19 coverage purchased from Myanma Insurance. Insurance Certificate must be attached to the application. The insurance can be purchased online (Detailed information can be obtained <a href="Myanmar Insurance Inbound Travel">Myanmar Insurance Inbound Travel</a>.)

## **Air-Port Arrival Process**

- 1. Travelers must present a printed copy of each document of CVOID-19 relevant and insurance to airline staffs upon check-in before boarding the aircraft destined for Myanmar as well as to the respective airport health authorities upon arrival to Myanmar.
- 2. Travelers must submit a Health Declaration Form to the respective airport health authorities upon arrival to Myanmar. (A legal action will be taken against a traveler, if he or she provides any incorrect information in the Health Declaration Form.)
- 3. Travelers shall be subject to a thermal screening and necessary health check to be conducted by the respective airport health authorities, upon arrival to Myanmar.
- Travelers must undergo a COVID-19 Antigen Rapid Diagnostic Test (RDT) at the place designated by the Ministry of Health and airport authorities and must bear the cost of 15,000 MMK.
- 5. Travelers who have obtained Online Visa are who are foreigners shall not be allowed to take relief flights.
- 6. Travelers shall report to the respective health authorities if they have developed signs and symptoms of COVID-19 during their stay in Myanmar. (Contact details of the respective health departments can be obtained from the designated hotels.)
- 7. Travelers shall be immediately isolated and taken to a hospital or treatment center or hotel designated by the MOH as per health protocols, if they are found to be symptomatic of COVID-19 or they are tested positive for COVID-19 during the RDT test.
- 8. If the result is negative, travelers are allowed to go about their activities.
- 9. Travelers must strictly follow the instructions made by the respective health authorities. Any breach will result in legal action in accordance with the existing laws and procedures.
- 10. The stipulations are subject to change depending on the COVID-19 situation.

## Public Health Requirements For Foreign Traveler



PUBLIC HEALTH REQUIREMENTS FOR FOREIGN TRAVELERS WHO WISH TO ENTER INTO MYANMAR THROUGH

COMMERCIAL AIR TRANSPORT (15-6-2022)

Foreign Travelers who wish to enter Myanmar through air transport must use the commercial flights and they must prepare the requirements according to their flight plan. After getting entry Visa and the commercial flight air ticket, document needed -- a COVID 19 fully vaccinated certificate at least 14 days before arrival to Myanmar, with one of the following vaccines which has been approved by OR a negative COVID-19 RT-PCR test issued at most 48 hours before arrival the Ministry of Health (MOH) - a COVID-19 medical insurance purchased from Myanma Insurance (The health insurance of Diplomats, UN officials and their family members from their respective countries will be accepted) - COVID-19 Rapid Test Requisition Form Check-in at airport health quarantine and immigration departments Swab taken in Airport Swab Counter and wait for RDT Test Result (the result will be given within 1 hour after the swab is taken) If RDT test is COVID-19 negative If RDT test is COVID-19 positive, the traveler will be isolated, If the traveler is fully If the traveler is unvaccinated/incomplete vaccination status or can't present transferred and treated in a vaccinated, can valid COVID-19 vaccination certificate, Quarantine at designated facility or hotel designated hospital or continue the trip (Home Quarantine for Diplomats, international staff from UN and their families) treatment center or hotel and COVID-19 RT-PCR Testing on Day 3 If COVID-19 RT-PCR test is If COVID-19 RT-PCR test is positive, the

# <u>Public Health Requirements (COVID\_19) For Travelers Entering Myanmar Through</u> <u>International Flights</u>

Travelers shall have the following documents:

- 1. The COVID 19 vaccination certificate showing that they were fully vaccinated, at least 14 days before arrival to Myanmar.
- 2. With one of the following vaccines which has been approved by the Ministry of Health (MOH)
  - CoronaVac (Sinovac Biotech Ltd.);
  - AstraZeneca or Covishield (AstraZeneca & University of Oxford/SK Bioscience (Korea)/Siam BioScience/ Serum Institute of India (SII));
  - Pfizer-BioNTech COVID-I9 Vaccine or Comirnaty (Pfizer Inc., & BioNTech);
  - Janssen or Johnson & Johnson (Janssen Pharmaceuticals Companies of Johnson & Johnson);
  - Moderna (ModernaTX, Inc.,);
  - Sinopharm or COVILO or BIBP-CorV (Beijing Institute of Biological Products Co., Ltd);
  - Sputnik V (Gam-COVID-Vac) (Gamaleya National Research Centre of Epidemiology and Microbiology);
  - Sputnik Light (Gamaleya National Research Centre of Epidemiology and Microbiology)
  - Covaxin by Bharat Biotech; and
  - Myancopharm by Ministry of Industry, Myanmar.
- 3. Nuvaxovid (NVX-CoV2373) vaccine, Novavax Co., Ltd (Children under 12 years old are exempted from this requirement if they travel with fully vaccinated parent(s) or guardian(s).
- 4. The country, name and date(s) of vaccination must be clearly stated in English and/or Myanmar, with the particulars of the travelers according to their passport.
- 5. A negative COVID-19 RT-PCR test result issued at most 72 hours before arrival to Myanmar (Children under 6 years old are exempted from this requirement The negative COVID-19 RT-PCR test result and the date of the test taken [or] information COVID-19 recovery must be clearly stated in English, with the particulars of the travelers according to their passport).
- 6. (For travelers who are foreigners) a COVID-I9 medical insurance purchased from Myanma Insurance. (Detailed information can be obtained at the Myanma Insurance's website







Myanma Insurance . Diplomats, UN officials and their families can submit the health insurance from their respective country)

- 7. A legal action will be taken against a traveler, if he or she provides any incorrect information in the Health Declaration Form.
- 8. Travelers shall be subject to a thermal screening to be conducted by the respective airport health authorities, upon arrival to Myanmar.
- Travelers shall be tested by RDT on COVID-19 at MOH and airport operators approved COVID-19 Rapid Diagnostics Test (RDT) testing counters at their own costs. Travelers will be charged 15,000 MMK for testing.
- 10. Travelers may leave the airport after receiving their test results showing negative for COVID-I9 from the respective health authorities.
- 11. (The test results will take approximately one hour to be conveyed by the respective health authorities.)
- 12. Travelers shall report to the respective health authorities, if they have developed signs and symptoms of COVID-19 during their stay in Myanmar.
- 13. Contact details of the respective health authorities can be obtained from the designated hotels.
- 14. Travelers shall be immediately isolated and taken to a medical facility or treatment center or hotel designated by the MOH as per health protocols, if they are tested positive for COVID-19 during the RDT test or they are found to be symptomatic of COVID-19.
- 15. Before departure from Myanmar, travelers may take COVID-I9 tests, as required by the countries they will travel to and transit through, at laboratories designated by the MOH, at their own cost.
- 16. Travelers who can't present the documents mentioned in the paragraph 1,2,3,4 and 5 may enter Myanmar only by relief flights, and shall fulfill the Quarantine and Testing Requirements of International Travelers to Myanmar issued and updated by the MOH. Vaccinated travelers will be quarantine for 3 days and unvaccinated travelers will be quarantine for 5 days. They will be tested for COVID-I9 during quarantine period.
- 17. (Travelers who are foreigners shall not be allowed to take relief flights to Myanmar from I7 April 2022 onward.)







- 18. The travelers shall strictly follow the instructions made by the respective health authorities and airport authorities. A legal action will be taken against the traveler concerned, if there is a breach of COVID-19 control regulations.
- 19. Foreigners are not allowed to transit through Myanmar.
- 20. State guests or foreign delegates visiting Myanmar by state flights or special flights may seek exemptions from the above requirements by submitting a request letter to the Central Committee for Prevention, Control and Treatment of COVID-19, the Ministry of Foreign Affairs and the MOH, at least (5) working days prior to the date of arrival.
- 21. Foreign air crew who need a layover in Myanmar are subjected to self-isolation at hotels designated by the MOH until their next flight, as per respective health protocols.
- 22. Travelers shall enter Myanmar only through Yangon International Airport.
- 23. These requirements are subject to changes. These requirements shall take effect from 1 May 2022 0000 hours Myanmar Standard Time.
